

## FLIR identiFINDER R100

### Monthly Sweepstakes Official Rules

NO ENTRY FEE OR PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

**1. Eligibility:** The Sweepstakes is open only to those who sign up at the online sweepstakes page and who are eighteen (18) years of age as of the date of entry. Employees of FLIR Systems, Inc. (hereafter "FLIR"), its respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited.

The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of FLIR. You may enter only once and you must fill in the information requested. You may not enter more times than once by using multiple email addresses, identities or devices in an attempt to circumvent the rules.
